<p>What is the overall deductible?</p>	<p>Network providers: \$1,700/individual, \$3,400/individual under family or \$3,400/family Out-of-network provider: \$3,400/individual, \$6,800/individual under family or \$6,800/family</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. The deductible is Non-Embedded. If you have other family members on the plan, the overall family deductible must be met before the plan begins to pay. Deductible year runs 01/01 – 12/31</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Preventive care services are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive care without cost-sharing and before you meet your deductible. Does this plan provide Minimum Essential Coverage? Yes

Peg is Having a Baby
(9 months of in-network pre-natal care and a hospital delivery)

- Primary care physician office visits (*including disease education*)
- [Diagnostic test](#) (*blood work*)
- Prescription drugs
- [Durable medical equipment](#) (*glucose meter*)

In this example, Joe would pay:
